NDC targets of Belarus

- INDC: unconditional target of -28% compared to 1990 by 2030 excl. LULUCF

- NDC: unconditional target of xx% compared to 1990 by 2030
- → not submitted yet

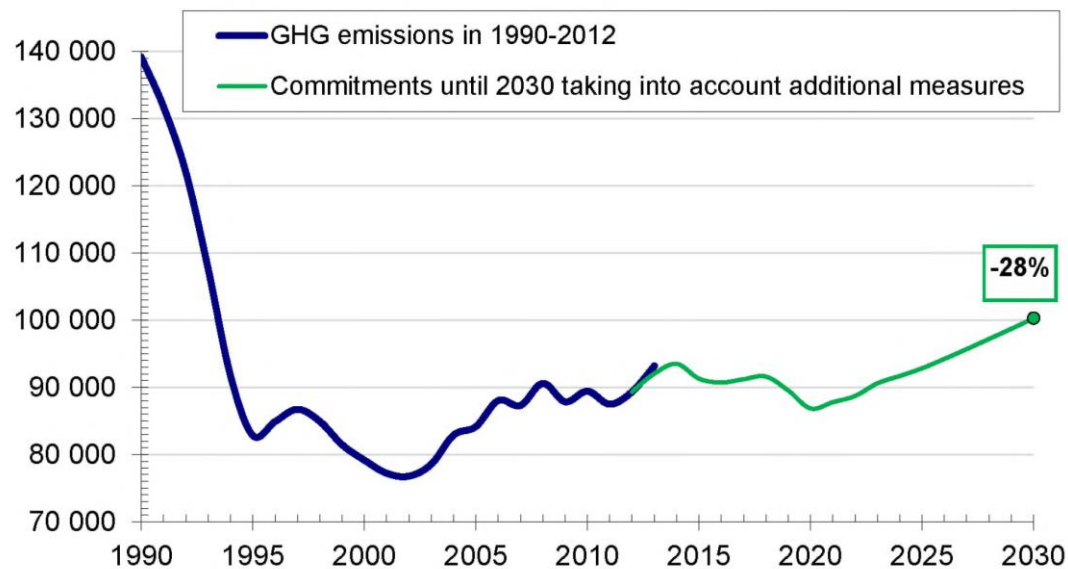
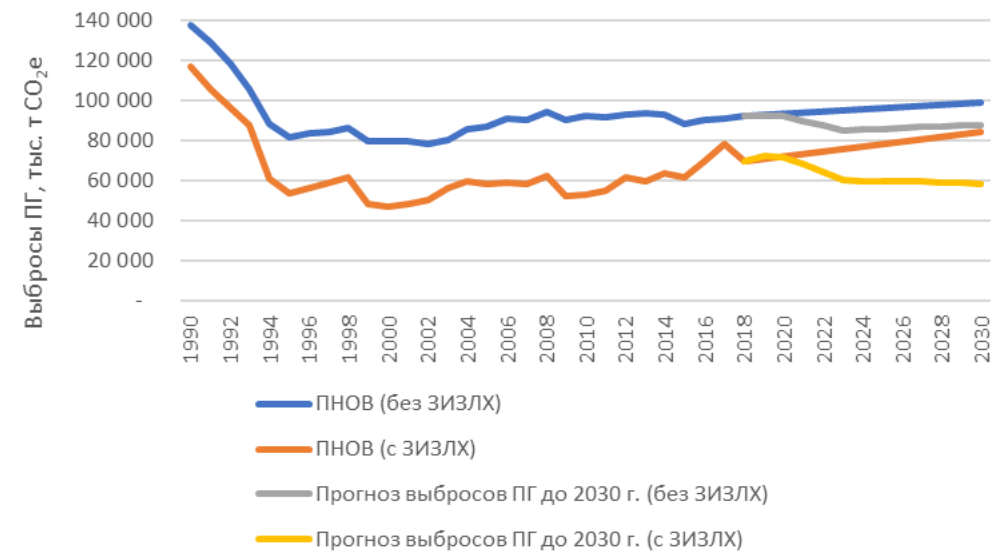
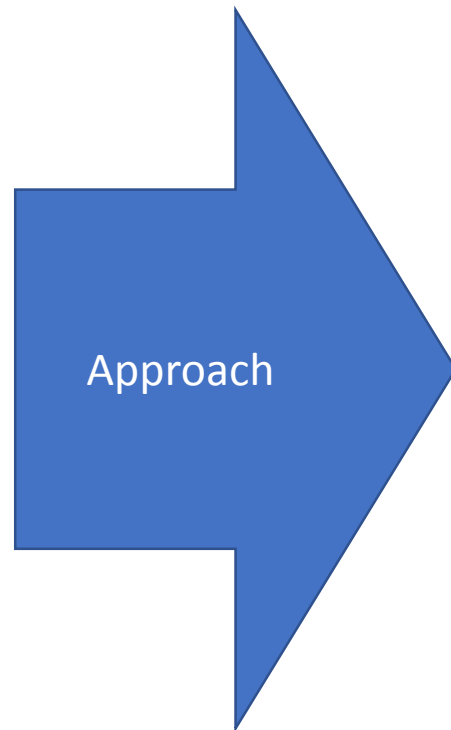


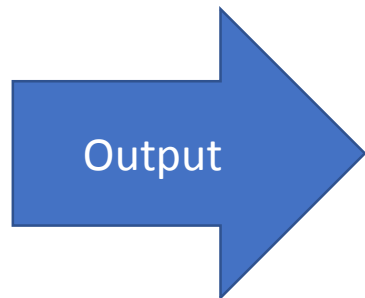
Figure 1 –Greenhouse gas emissions in 1990-2030, Gg CO₂ eq.



Process in Belarus



1. Analysis of total and sectoral GHG emission trends
2. Review of national strategies
3. Analysis of sectoral policies and measures
4. Assessment of financial flows + Recommendations
5. Forecast scenarios with moderate and optimistic economic forecast on sector level
 - With existing measures (Business as Usual)
 - With additional measures
6. Assessment of possible NDC targets
7. Analysis of adaptation actions and vulnerabilities
8. Assessment of Gender Equality
9. Stakeholder Involvement
 - Review of documents (late 2020)
 - Stakeholder Meeting (February 2021)
 - Governmental Decision on NDC target

NDC targets in Moldova

	Unconditional target	Conditional target (*)
INDC	64-67% below 1990 level in 2030	78% below 1990 level in 2030
Updated NDC	70% below 1990 level in 2030	88% below 1990 level in 2030

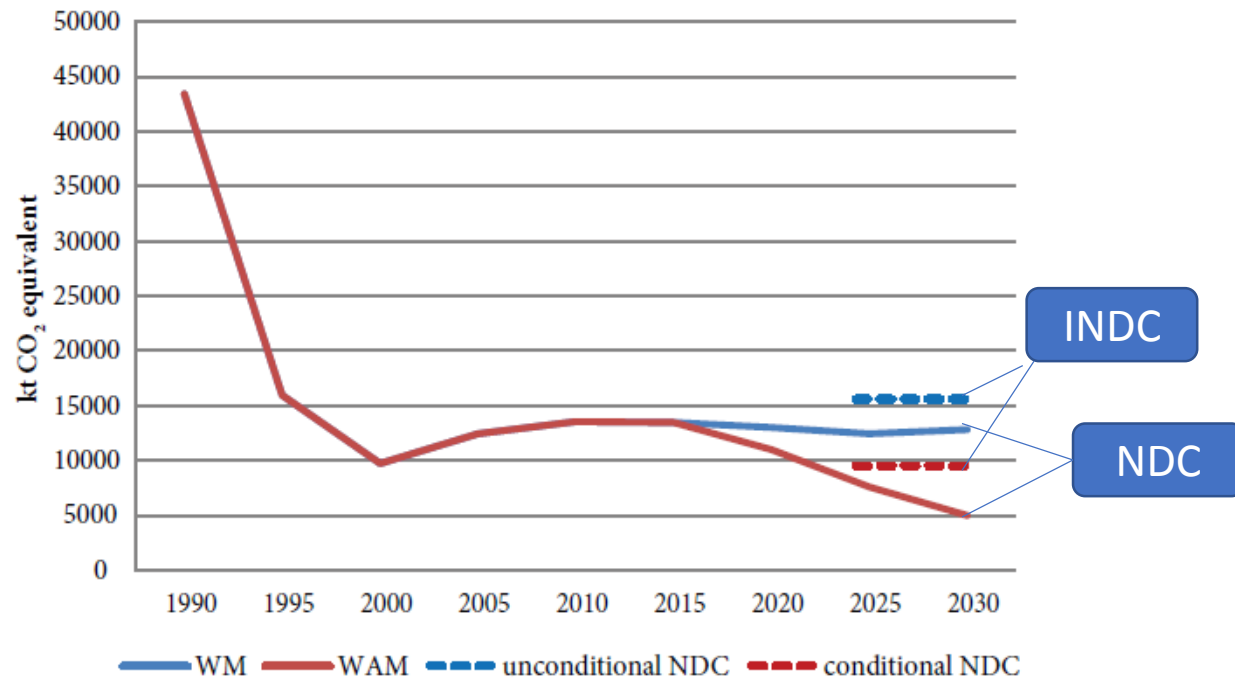


Figure 4-1: Projected net (including LULUCF) total GHG emissions under the considered scenarios.

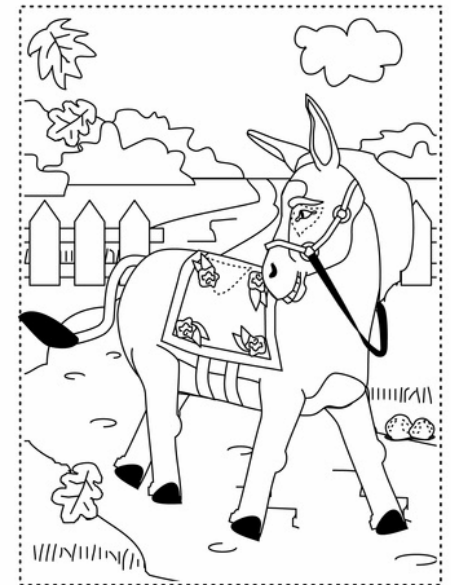

Process in Moldova

- Preparatory work: Review of MRV system in view of the ETF
- Robust GHG inventory and report
- Basis for NDC:
 - second BUR from 2019 including NIR
 - Mitigation policies and measures included herein, already discussed with national stakeholders
 - WEM and WAM projections → updated NDC target
- Strong Adaptation component: based on NAP 1, adaptation priorities, sector specific adaptation actions, investment priorities, extensive consultation process
- Stakeholder consultation:
 - During BUR2 preparation
 - Open for comments on public website
 - Discussion and validation during national consultation workshop

Ensure Consistency between NDC and ...

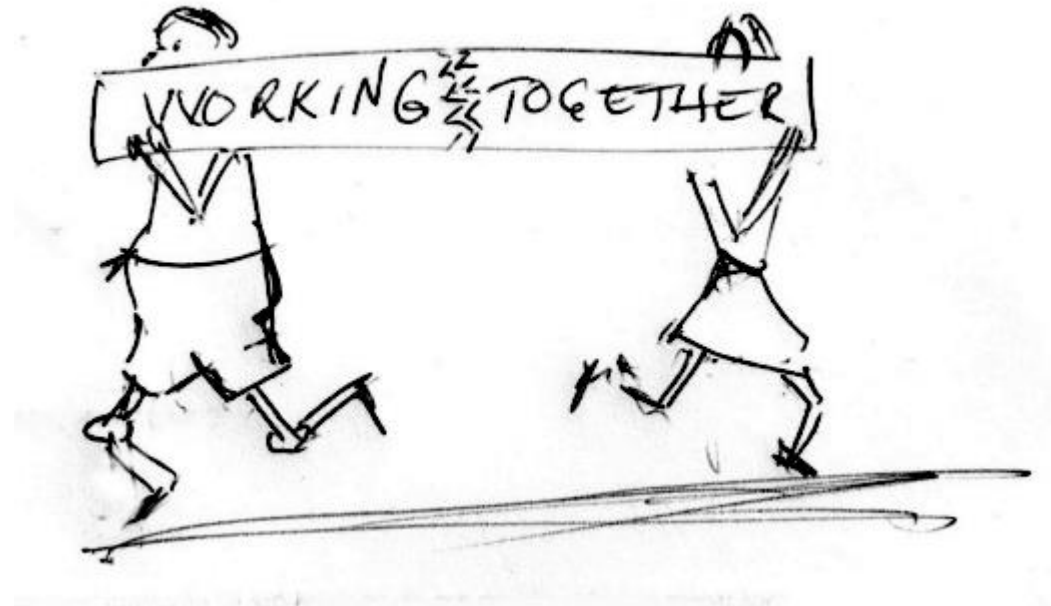
- GHG inventory
- LEDS
- Biennial Update Report → Biennial Transparency Report
- National Strategies: e.g.
 - National Sustainable Energy Action Plan of Azerbaijan
 - National Development Priorities
 - NECP – if applicable
- Why?
 - Mainstreaming
 - Efficient use of resources
 - Increase credibility, coherence and integrity
 - Facilitate implementation



Involvement of Stakeholders

- NDC is a political commitment to be supported across all levels
- Create ownership, responsibility and sustainability
- Requires coordination across policy levels
- Facilitate implementation of policies and measures through various policy instruments (economic, fiscal, educational, regulatory, ...)
- Ensure inclusiveness → leave no one behind

Stakeholders: public bodies, civil society, marginalised groups, educational institutions, private sector representatives, major industrial facilities, NGOs, ...



Plan for tracking progress

- What? → MPGs for ETF (Decision/CMA.1), Biennial Transparency Report
- Why? → Global Stocktaking (Decision 19/CMA.1)
- Where? → Biennial Transparency Report + NIR (<31 Dec 2024)
- How? → Indicators, total GHG (incl. /excl. LULUCF as applicable)

consistent with NDC target

- Qualitative or quantitative
- Reference information
- Historic and recent development
